PRESIDENT'S MESSAGE – Joseph D. Pluta



Aloha Members and Friends of West Maui!---Happy New Year! Hauoli Makahiki Hou!

Many of you may make “New Years’ Resolutions,” at the start of each year. We hope that you will join with us and resolve to make life saving acute emergency medical care available here in West Maui one of your highest priorities.

Did you know that West Maui is the only location in the entire United States where a community with an average daily census over 50,000 with \$11 Billion Dollars in Property Assessed Valuations is isolated on a roadway frequently closed and over an hour away from 24/7 Acute Emergency Medical Services? Maui County Government relies upon property tax revenues for its highest source of income, and West Maui provides over 50% of total revenues for the County of Maui. West Maui has over 50% of the total transient accommodations in Maui County, so the General Excise Tax and Transient Accommodations Taxes represent the majority of tax revenues from Maui to the State of Hawaii. Words fail to adequately describe how illogical it is to ignore the essential need for acute emergency medical care to protect and preserve these financial resources!

It is clear that the number one priority for the WMTA and the WMIF and all those who love Maui, should and will be establishment of essential life-saving Emergency Acute care accessible within the “golden hour,” here in West Maui.

We started an effort over 20 years ago to obtain access to Acute Care Emergency Medical Services. We obtained a Certificate of Need that we were told would be impossible to obtain. Just when we thought we had achieved success and despite repeated statements that the developer was moving forward with the West Maui Hospital, he changed his course and has abandoned his plans for the Critical Access Hospital. While he changed his mind, the community needs have not changed. We are going to reactivate our West Maui Hospital and Medical Center Foundation Inc. and re-establish a campaign to obtain life-saving acute care emergency medical services here in West Maui. Time is of the essence. Help us to help you and make a commitment now. We know what needs to be done and we know we cannot do it without your financial assistance.
