With the Primary election behind us, all eyes are now focused on the November 2, 2010, election. WMTA and the Lahaina News co-sponsored an unprecedented pre-primary candidates' night on August 15, 2010, to give candidates for the West Maui Council seat an opportunity to introduce themselves to voters.

This year the WMTA Candidates' Night will be at the Lahaina Civic Center on Thursday, October 21, 2010. This is always a well attended and informative event, and all West Maui voters are urged to attend.

WMTA and the West Maui community are grateful we have had a respected and experienced Joanne Johnson in the West Maui Council seat for the past several years. Council Member Johnson and WMTA have enjoyed a working relationship that served West Maui very well. Whatever the results of the November election, the West Maui seat will be occupied by a less experienced Council Member who will need community and WMTA input to competently address all the serious issues in West Maui.

WMTA is ready and willing to work with the new council member to protect and preserve West Maui, but we will need your help to be ABLE to provide that help. The WMTA Board appreciates the support from the community over the years, but when many in our community are struggling financially, so is WMTA. *In the 2010 Primary Election, Maui County had 84,386 registered voters.
Only 28,839, or 34.2 percent, cast ballots in the primary election.*

WHY AREN'T PEOPLE VOTING?? VOTER APATHY IN PRIMARY ELECTIONS WAS MOST EVIDENT IN WEST MAUI THIS YEAR. BY JOSEPH PLUTA

The State Elections office web site presents statistical facts on the recent statewide primary elections. Please check out the alarming facts. Why aren't people voting! The 34.2% of registered voters who turned out to vote on the September 18th primary is pathetic. Worse yet, is the fact that of the 28,839 who did vote, 5,424 of them; almost 19%, did not even cast a single vote for any West Maui candidate. There is not any more evidence necessary to see that West Maui is an island unto itself. It seems it's not on the minds of voters who forget that the successful West Maui Candidate will be voting on all issues which come before the Maui County Council. That means where they live too in Central Maui and elsewhere. We may be in different life rafts in West Maui than East Maui, Central, Kihei and Upcountry, but we're all in the same boat.


We have some great community and fair minded residents on Maui in all locations. However, it seems that some Voters who do not reside in West Maui; suffer from "tunnel vision." It seems that they lose sight about West Maui's importance at the Pali Tunnel. These voters need to be reminded to recognize the fact that nearly 45% of the entire County and State Economic Tax contributions are derived from West Maui. Who they select for the West side will be of vital importance and should not be ignored with blank votes.

The blank vote number of 5,424 for West Maui could have swung the election in the favor of every other candidate who was not successful to be selected to move to the general election. That means that the total votes for the two who did move on, Elle Cochran and Alan Fukuyama, are representative of just less than half of those who did vote and only 16% of the registered voters in Maui County.

That is a troubling statistic. We hope that the people who have investment interests in West Maui will recognize the importance of having the West Maui Taxpayers Association's assistance and guidance available to bring to the Council meetings next year. We will be urging both of these candidates to contract us and familiarize themselves with our short and long term goals which the community at large has expressed to the WMTA each year. The magnitude of importance is off the charts.

TRANSPORTATION UPDATE BY BOB PURE



1. Keawe Street Intersection: The work has been completed. Exiting the Lahaina Gateway Shopping Center, there is now a dedicated left turn lane with a green arrow allowing motorists to make an unobstructed left turn towards Lahaina.
2. Highway Widening Project LahainaLuna Rd. to Aholo St: Work is ongoing and on schedule. When completed there will be a landscaped tree lined median going down the center of the road the entire length of the project. Coming into Lahaina will look a lot better than it does now.
3. Phase 1-A , Lahaina Bypass: Work is also ongoing and on schedule. The contractor is planning to have Lahainaluna Rd. revert to its original traffic configuration by the end of October. Concrete has already been poured for the foundation of the bridge with major progress on bridge construction to take place in November.
4. Phase 1-B-1, Lahaina Bypass (from Lahainaluna south to Hokiokio Place): Ground broken to begin this project on Friday October 1st. A public information meeting (PIM) is planned to be held sometime in October.

In summary: in West Maui, we have one project completed with three under current construction. When all of these projects are completed, getting around and into and out of West Maui, will be much easier for visitors and residents alike.
