PRESIDENTS MESSAGE



At our WMTA Annual Meeting held last January 9, 2018, over a hundred people came to listen to our Speakers, ask questions and voice out their concerns that are affecting our lives on West Maui, affordable housing, community plan, transportation, and West Maui hospital update.

A lot of very important questions and concerns were brought out, and one in particular is the Keawe Street improvements and bypass extension. Most, if not all who were in attendance were concerned about the “unintended consequences” of the project designed to improve the traffic through this area.

We presented our suggestion to the County and to the Department of Transportation what we believe will best serve the community given that the designed used was over a decade old that did not take into consideration the businesses and homes that are now in the neighborhood. Unfortunately, Hawaii Department of Transportation will proceed with their design and plan for the traffic shift from Honoapiilani Highway at Olowalu/Cut Mountain to the Southern Terminus of the realigned highway will take place next month.

As in years past, this year WMTA will host two candidate forums. The first forum will be held on Wednesday July 25, 2018, at the Lahaina Civic Center Social Hall. The second forum will be held after the Primary Election and will Thursday, October 18, 2018

On West Maui, only 28% of the registered voters exercise their power to make a change and to make a difference; we need to do better if we want to be heard. **My VOICE – My VOTE** is a plan that we at WMTA is working on to help register voters and to ensure that our West Maui registered voters go out to vote.

The mission of the West Maui Taxpayers' Association is to advocate the concerns of the people of West Maui. WMTA relies on membership dues and donations to help with this effort. However, in order for WMTA to more successful in pursuing its Goals and Objectives that will benefit West Maui, we need financial support. A support of \$25 is what it takes for an individual to become a Member and \$100 will make an entire family become a Member of the WMTA.

**Help West Maui develop
a community emergency plan**

For months now, the West Maui Taxpayers Association (WMTA) has been working with the Maui Emergency Management Agency, Pacific Disaster Center and the State Emergency Management Agency to develop a customized disaster plan designed to meet West Maui's specific needs.

The next meeting, "This is Not a Drill," on Wednesday, Feb. 28, at 5:30 p.m. at the West Maui Senior Center should be interesting.

General Bruce Oliveira, community programs director at the Hawaii State Department of Defense, will lead the meeting on the topic of developing a community emergency plan.

Oliveira was scheduled to speak last month, but he was tied up due to his urgent responsibilities as leading official in the internal investigation of Hawaii's false missile alert.

Disaster response agencies identified the need for an emergency plan due to the region's isolation from Maui Memorial Medical Center and Kahului Airport due to frequent road closures, fires and flooding.
